Waiver of Liability, Indemnity Agreement, and Assumption of Risk

Waiver: In consideration of permission to use, today and on all future dates, the property, facilities and services of Academy of Modern Martial Arts and its employees, I on behalf of myself, my heirs, personal representatives, or assigns, do hereby release, waive, discharge and covenant not to sue Academy of Modern Martial Arts, its owners, employees, volunteers, independent contractors, and agents from liability from any and all claims arising from the ordinary negligence of Academy of Modern Martial Arts or any of the aforementioned parties. This agreement applies to: 1) personal injury (including death) from accidents or illness arising from participation in Academy of Modern Martial Arts activities including, but not limited to, organized activities, classes, observation, and individual use of facilities premises, or equipment; and to 2) any and all claims resulting from the damage to, loss of, or theft of property.

Indemnification and Hold Harmless: I also agree to hold harmless and indemnify Academy of Modern Martial Arts from all claims resulting from ordinary negligence and to reimburse them for any expenses incurred as a result of my involvement with Academy of Modern Martial Arts. I further agree to pay all costs and attorney's fees incurred by Academy of Modern Martial Arts in investigating and defending a claim or suit if my claim is withdrawn, or to the extent a court or arbitration determines that Academy of Modern Martial Arts is not responsible for the injury or loss.

Assumption of Risks: Physical activity, by its very nature, carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. Academy of Modern Martial Arts has facilities for activities such as walking, jogging and running, and aerobic activities. The specific risks vary from one activity to another, but in each activity, the risks range from 1) minor injuries such as scratches, bruises and sprains to 2) major injuries such as loss of sight, joint or back injuries, concussions and heart attacks to 3) catastrophic injuries including paralysis and death.

I have read the previous paragraphs and I understand the demands of those activities relative to my physical condition and skill level, and I appreciate the types of injuries which may occur as a result of activities made possible by Academy of Modern Martial Arts. I hereby assert that my participation is voluntary and I knowingly assume all such risks.

Severability and venue: The undersigned further expressly agrees that the foregoing waiver and assumption of risk agreement is intended to be as broad and inclusive as is permitted by the law of the State of Texas and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect. Likewise, I agree that if legal action is brought, it must be brought in Brazos County, Texas.

Acknowledgement of Understanding: I have read this waiver of liability and indemnification agreement and fully understand its terms. I understand that I am giving up substantial rights, including my right to compensation for injury. I acknowledge that I am signing the agreement freely and voluntarily, and intend my signature to be a complete and unconditional release of all liability for ordinary negligence to the greatest extent allowed by law in the State of Texas.

Transportation: I give my permission for my child to ride in personal vehicles of Academy of Modern Martial Arts employees or volunteers to the swimming pool.
